To purchase the bidding documents, eligible Bidders should write to address above requesting the bidding documents specifying the contract nos. and Title given in clause 11, and pay a non-refundable fee for each set as specified in clause 11 in Nepali Rupees, or its equivalent in a free-convertible currency. For the purpose of Bidders who choose to submit their bid electronically through e-GP system :www.bolpatra.gov.np/egp. Interested bidders shall register in the e-GP system, the Bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document (as specified in the table below) in Office Rajaswa (revenue) account either by direct deposit or by Tele-transfer of deposit in the Office account for the purchase the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files

- 6. Bids must be valid (Bid Validity/Bid security Period, specifying in the contract nos. and Title given in clause 11, below table

 The Bid Security shall be in the form of a bank guarantee from a bank acceptable to the Purchaser or a cash voucher deposited in the

 Bank Account of the Purchaser specified, the cash should be deposited at office bank account, Prime Commercial Bank, ShahidLakhan

 Branch, Ghairung, Gorkha, Account No. 05800027CA and submit the receipt of the ShahidLakhan Rural Municipality, Office of

 Rural Municipal Executive.
