Interested bidders shall register in the e-GP system, the Bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. - 5. Bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2075-10-24 BS at the Shahid Lakhan Rural Municipality, Office of Rural Municipal Executive Ghairung, Bids will be opened even the absence of Bidder's representatives at date.
- 6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security for the amount as specified in clause 11 and valid for 30 days beyond bid validity period The Bid Security shall be in the form of a bank guarantee from a bank acceptable to the Purchaser or a cash voucher deposited in the Bank Account of the Purchaser specified, the cash should be deposited at office bank account, Prime Commercial Bank, Shahid Lakhan Branch, Ghairung, Gorkha, Account No. 05800027CA and submit the receipt of the Shahid Lakhan Rural Municipality, Office of Rural Municipal Executive.
